## 1.1 TECHNICAL EQUIPMENT AND REGISTRATION TO THE PLATFORM

In order to participate in the tender, competitors must be registered on digital platform of Provincia Autonoma di Trento " (Attention! Not to the electronic marketplace - MEPAT). The economic operator is required to register by accessing the following link:

## 3.1.2 TECHNICAL ANNEX: TECHNICAL OFFER

The economic operator enters the technical offer in the digital platform as "Technical Annex:

a) Annex 4\_Technical Offer Form.

The characteristics of the Technical Offer with reference to the evaluation criteria and sub-criteria indicated in the table referred to in the following point n. 4, are as follow:

a) Air temperature inside the chamber

Competitor must indicate in Annex 4 whether the thermal chamber is capable of achieving an air temperature inside the chamber of 1200 °C.

Offer with a maximum temperature of less than 1010°C will be excluded.

b) Heathing rate

Competitors must indicate in Annex 4 whether the thermal chamber is capable of heating at a speed between 2 K/min and 50/K min, with the two limits within the operating range.

### 2 Warranty

Competitor must indicate in Annex 4 the period, of the warranty service

Offer with a period of warranty less than 24 months will be excluded

3.1.3 ECONOMIC ANNEX: ECONOMIC OFFER

The Economic Operator enters the economic offer in the digital platform as "Economic Annex" which must contain, under penalty of exclusion, the following documents:

- 1. summary document deriving from the economic offer prepared in a digitally signed system, with the following elements:
- a) percentage reduction on the total amount, net of VAT and / or other taxes and contributions required by law, as well as safety charges due to interference risks. (Up to three decimal places will be considered.)
- b) estimate of company costs relating to workers' health and safety in the workplace, pursuant to art. 95, paragraph 10 of the Code. These costs related to health and safety connected with the business activity must be consistent with the entity and characteristics of the supplies and services covered by the contract.
- c) estimate of workforce costs (related to the tender's object), pursuant to art. 95, paragraph 10 of the Code.

Economic offers that exceed the total tender amount are inadmissible.

## 4. EVALUATION CRITERIONS OF THE TECHNICAL OFFER

The score of the technical offer is assigned on the basis of the evaluation criterions listed below, with the relative breakdown of scores.

If a Competitor fails to check a technical characteristic being evaluated, a zero score will be awarded for that criterion. During the technical verification, the competitor must prove that said missing values, if required as minimum requirements, comply with the performance specifications. If the Competitor crosses more than one option, for criteria where the choice of only one option is provided, the score relating to the option with lower score will be awarded.

The column identified by the letter T indicates the "Table Scores", are the fixed and predefined scores that will be assigned or not assigned due to the offer or non-offer of what is specifically requested.

# CONDUCT OF TENDER OPERATIONS

In the first session, the person in charge of the Tender procedure, assisted by two witnesses, will proceed opening the administrative Annex of each Competitor, while the technical offers and the economic offers remain closed, secret and blocked by the Digital Platform.

The date and time of opening of the Technical offers will be communicated by a certified e-mail communication.

Once the administrative documentation has been checked, the person in charge of the tender procedure, in a public session, will proceed to open the Technical Annex to the System and verify the presence of the documents required by these Regulations.

In one or more reserved sessions, the person in charge will proceed with the examination and evaluation of the Technical Offers and the assignment of the scores, applying the criterions indicated in the tender documentation.

Subsequently, in a public session, the person in charge of the tender procedure will read the scores assigned to the individual technical offers and will acknowledge any exclusion of the Competitors from the tender.

In the same session, or in a subsequent session, the person in charge of the tender procedure will proceed with the opening of the Economic Annex to the System and then with the relative assignment of scores.
